NOTICE REGARDING FEES PAYABLE TO THE COUNCIL IN TERMS OF
THE REGULATIONS RELATING TO THE PARTICULARS TO BE
FURNISHED TO THE COUNCIL FOR KEEPING OF THE REGISTER FOR
NURSING PRACTITIONERS, THE MANNER OF EFFECTING
ALTERATIONS TO THE REGISTER, AND CERTIFICATES THAT MAY BE
ISSUED BY THE COUNCIL

DEFINITION

1. In this notice, “the regulations” means the Regulations Relating to the Particulars to be Furnished to the Council for Keeping of the Register for Nursing Practitioners, the Manner of Effecting Alterations to the Register, and Certificates that may be Issued by the Council published by Government Notice No. R. 195 of 19 February 2008.

ANNUAL FEES

2. The amounts of the annual fees, referred to in 8(1)(a), 9(2) and 11(1) of the regulations, have been determined by the Council as shown in the table below.
3. These amounts apply to annual fees in respect of the calendar year 1 January 2012 to 31 December 2012, which may be paid from 1 July 2011, and which must be received by Council before or on 31 December 2011 (final date for payment).
4. These annual fee amounts will apply to all subsequent annual fee years until such time that the fees are amended by a notice in the *Gazette*.
5. The 25% discount applies to practitioners who are or will be 60 to 64 years of age on 1 January 2012.
6. The 50% discount applies to practitioners who are or will be 65 years of age or older on 1 January 2012.

(*) To qualify for the 25% discount, a practitioner must be 60 to 64 years of age on 1 January 2012.

(**) To qualify for the 50% discount, a practitioner must be 65 years of age or over on 1 January 2012.

RESTORATION FEES

7. The amounts of the restoration fees, referred to in 9(2)(a) and (b) of the regulations, have been determined by the Council as shown in the table below.
8. These restoration fee amounts will apply from 1 January 2012.
9. The reduced restoration fee only applies to those practitioners who were removed from the register at their own request.

WOORDOMSKRYWING

1. In hierdie kennisgewing beteken “**die regulasies**” die Regulasies Betreffende die Besonderhede wat aan die Raad Voorsien moet word om die Register van Verpleegkundige Praktisyne in Stand te hou, vir die Maniere waarop Wysigings in die Register Aangebring kan word en die Sertifikate wat deur die Raad Uitgereik mag word soos aangegee in Goewermentskennisgewing No. R. 195 van 19 Februarie 2008.

JAARLIKSE GELDE

2. Die bedrae van die jaarlikse gelde, na verwys in 8(1)(a), 9(2) en 11(1) van die regulasies, is deur die Raad bepaal soos aangetoon in die tabel hieronder.
3. Hierdie bedrae is van toepassing op jaarlikse gelde ten aansien van die kalenderjaar 1 Januarie 2012 tot 31 Desember 2012, wat vanaf 1 Julie 2011 betaal mag word, en wat voor of op 31 Desember 2011 (die finale betaaldatum) deur die Raad ontvang moet word.
4. Hierdie bedrae van die jaarlikse gelde is van toepassing in alle latere jare tot op sodanige datum dat dit deur 'n kennisgewing in die *Staatskoerant* gewysig word.
5. Die 25% afslag is van toepassing in die geval van praktisyne wat op 1 Januarie 2012 60 tot 64 jaar oud is, of sal wees.
6. Die 50% afslag is van toepassing in die geval van praktisyne wat op 1 Januarie 2012 65 jaar oud of ouer is, of sal wees.
